### Last year the Partnership:

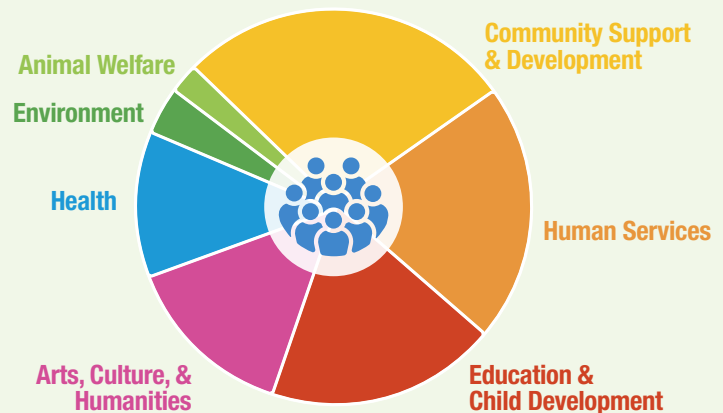
Provided **1,596** hours of free legal help to environmental nonprofits, valued at more than **\$850,000**
